Does Laura Smith know anyone that owns and carries a weapon? (**YES**)

Does Laura Smith know the difference between a revolver and automatic pistol and if so, how? (**YES**)

On June 21, 2007, what was the policy on cutting evening employees or closing sections? (**Westside 1st**)

Was the west side closed to further seating of customers prior to Mr. Goldberg arriving at the To Go Area at approximately 9:45pm and if so, at what time? (**YES**)

Were the west side "To Go Area" employees cut first on June 21, 2007, and at what time? (**YES**)

Were there any customers in the west side seating area when James Goldberg walked in? (**NO**)

Who were the employees assigned sections on the west side on June 21, 2007? (**Kristen Shipee, Michelle Grabo, Brett**)

Were any customers asked to move or leave the To Go Area prior to the arrival and entry of the Glastonbury Police officers? (**NO**)

Were the employees in the To Go Area rolling silverware or other assigned Side work tasks? (**YES**)

Were the employees seated near the To Go Area instructed to leave the area prior to ~~or after~~ the arrival of the Glastonbury Police Officers entered the restaurant?

Has anyone from the Glastonbury Police Department or Connecticut Department of Public Safety answered the permit question you posed in your initial contact with the 911 dispatcher?

"IS THERE ANY SUCH THING AS A NON COCEAL CARRY PERMIT" (**YES Male and Female State Police**)

Is it possible that some of the words or phrases contained in your statement were suggested and/or written by the Detective taking your statement? (**YES – PISTOL NOT MINE – SHE CAN'T REMEMBER IF A COPY WAS LEFT**)

Would it surprise you to learn that documents generated by law enforcement claim that customers were alarmed and upset? (**YES!!!**)

Since your initial 911 call on June 21, 2007, has anyone explained the law(s) regarding permits to carry firearms and/or where a weapon can be legally carried? (**YES**)

Are you aware of any policy of Brinker International on firearms being carried into their establishments? (**HAD AND HAS POLICY REGARDING EMPLOYEES CARRYING WEAPONS**)

(**States that Interview(s) of two employees present on June 21, 2007 may have been recently conducted by State Police Kristen and Michelle**)
